- \* There is no tape or pinning on facility walls, post or floors.
- \* All prices and fees must be clearly marked.
- \* All spaces are by a first come basis and will be processed in order.
- \* We are limited to 18 Psychics. You may purchase a vendors booth to sell product and also offer psychic services this will help to bring in even more product and services for the clients to choose from.

You must sign up to give a lecture and they are on a first come basis. You will have 45 min to discuss your topic.
